# Immediate Steps After Injury

### **Report the Injury Promptly**

#1 Inform your supervisor immediately.

#2 Request and start completing a DWC-1 Claim Form.



### COMMON MISTAKE TO AVOID

Waiting too long to report your injury. Timely reporting supports your claim.





# Document the Injury Properly

### **Complete the Claim Form. Include:**

#3	Date, time, and exact location.
#4	Description of how it occurred.
#5	Specific body parts or systems affected



### **QUICK TIP**

Always keep a copy of your completed form for your records.





## Medical Attention and Follow-up

### **Seek Immediate Medical Care**

#6 Follow your employer's initial referral to an industrial medical provider.



COMMON QUESTION:
Can you choose your doctor?
Typically, employers initially select your medical provider, but options can change later.





### Follow Medical Recommendations

### **Adhere Closely to Doctor's Orders**

#7 Follow work status instructions: off-work, modified duty, or full duty.

#8 Obtain written documentation clearly outlining your work status.

#9 Immediately inform your employer of any work restrictions

Ignoring medical instructions, potentially jeopardizing your claim.





# Understanding Disability Benefits

### **Know Your Eligibility**

#10 If unable to work or working with restrictions, confirm your eligibility for temporary disability benefits.



### **Did You Know?**

The average duration of temporary disability in California varies significantly by injury and industry.





### Watch for Claim Issues

### **Monitor for Delays and Denials.**

### Common issues include:

- Employer or insurer delays
- Denial of benefits without clear reasons



### **Did You Know?**

If complications arise, professional guidance can help clarify your next steps.





# Workers' Compensation Terms You Should Know

**Temporary Disability Benefits:** Payments received when a doctor says you cannot work because of your injury.

Maximum Medical Improvement (MMI): The point when your medical condition stabilizes.

Independent Medical Review (IMR): Review of medical disputes by independent doctors.



# Self-Assessment Checklist

Have you reported your injury immediately?
Have you documented all details on your claim form clearly?
Are you keeping track of your medical documentation?
Do you know if you're eligible for temporary disability benefits?




